Commissioner Zellers called the meeting to order.

Commissioner Zellers welcomed Senator Travis Fitzwater to the Missouri Consolidated Health Care Plan (MCHCP) Board of Trustees. He also welcomed John Wiemann to the meeting today. Mr. Wiemann accepted the position of MCHCP Executive Director effective May 19, 2025.

Additionally, Commissioner Zellers reminded board members that the deadline for filing a personal financial disclosure to the Missouri Ethics Commission is May 1, 2025, to avoid penalty.

Director Nelson made a motion to approve the open session minutes of the March 27, 2025, regular MCHCP Board of Trustees meeting. Representative Griffith seconded. Motion passed unanimously.
